开场

主席向借出场地的怡和轩俱乐部主席林清如致谢,也感谢李经雄律师及所有在场者的拨冗出席。

主席扼要报告过去两年主要活动:

- 第五届东盟民间友好组织大会在新加坡盛大举行
 - o 2010年7月28日至30日于圣陶沙名胜世界举办。
 - 协办:南洋理工大学南洋公共管理研究生院、新加坡国立大学东亚研究所、新中科技促进交流会、南洋理工大学孔子学院和新加坡乐龄活动联会。赞助:中国银联、华源会、李氏基金、永泰和企业私人有限公司、莆田饮食集团和世界科技出版公司。名誉赞助:中华人民共和国驻新加坡共和国大使馆。支持机构:通商中国、新加坡旅游局、中国国际贸易促进委员会和新加坡中国商会。

- 中国东盟协会会长顾秀莲女士认为新加坡主办的第五届东盟民间 友好组织大会很成功。在泰国曼谷举办的第六届东盟大会还特别 邀请了本会主办其中的"东盟-中国高等教育论坛暨研讨会"。此外, 第六届,甚至第七届于越南举办的东盟大会将采用第五届的大会 标志。
- 过去一年半与中国大使馆的关系进一步加强,交流活动次数增加,为会员制造了更多沟通、交流与合作的机会。
- 中国各高等院校在新加坡的校友会已有 10 余个,包括北京大学、清华大学、厦门大学等,本会会员董旭即为上海交通大学校友会会长。本会会尽量促进与各校友会的合作关系,毕竟学术和文化是建立友好关系之重要途径。
- 一如既往地接待中国来新代表团,也积极组团访问中国。

一、复准2010年2月26日第十六届会员大会会议记录

- 水铭漳建议由于时间有限,会员可取回再细审,有问题才书面通知秘书。
- 主席特别向创会会员水铭漳致谢,感谢水先生在身体不便的情况下仍然 坚持出席会议。
- 有关前期会员大会会议记录,林清如认为应该现场进行审核,若无异议,则由一人提议,一人复议通过。

有关第十六届会员大会会议记录,与会者经过现场审核后无异议,由蔡德明 提议,罗荣基复议,通过。

二、审计后的财务报告(财务年度: 2009年3月至12月)

- 胡名正表示不能认同 2 次会员大会一起召开之做法,也不能接受上一份 财政报告,认为不合法规,因此提出要离开会场。黄锦西劝请他留下了 解相关原因及详情,他也可以向会员进一步说明他的看法,但胡名正坚 持在会议进入第一项议程之前离席。
- 黄锦西指出,有人向会员发电邮,说会员大会若通过账目,全体会员都要负责。该电邮也质疑他(黄锦西)担任秘书是否符合章程规定。



• 黄锦西澄清说,社团账目若有问题,只有董事会和查账需要负责。依照 友协章程,在会员大会上,会员只需考虑(consider),无需批准 (approve)。

至于委任秘书一事,根据章程第 24 条,董事会是可以指派给任何董事任 何任务。他被指派负责秘书的工作。也有人提出董事会应按民主程序办事。黄锦西指出民主的精神在于"少数服从多数"。董事会就是按这个原则办事的。希望会员不要被一些群发电邮影响。

• 有关审计后的财务报告(2009年3月12日),与会者经讨论后,由林清如提议,水铭章附议,通过。

三. 审计后的财务报告(财务年度: 2010 年)

- 张瑞良认为不符合规定,表示反对。他也表示曾向董事会要求召开 EGM, 但未被受理。
- 针对有电邮指董事会不按章程办事,没有每两个月召开一次董事会。黄锦西澄清说董事会已尽量按章程行事。在2010年,新中友协忙着筹备第五届东盟大会。那年全体理事共召开了14次会议(4次董事会会议及10次东盟筹备委员会会议(全体董事皆为东盟筹备委员)。除此外还有许多工作小组会议,没有时间再按每两个月开一次董事会。这种情况,很多会员都能理解。
- 也有人指友协曾开出数额超出一万元的支票,违反章程第21条(a),即董事会有权批准不超过一万元的开销。黄锦西说这几笔钱并非经常性开销,而是开给新疆的捐助及四川地震的捐款,并没有违背章程第21条(a)的规定。至于东盟大会的费用,潘会长曾向董事会宣布要负责不敷之数目。实际上他为大会的举行花费超过了7万3千元(实际数目为S\$73,376.32)
- 林清如说东盟大会大家都应该支持。他个人就捐了两千元。他认为任何会员对董事会如有任何不满,应直接向董事会提出,而不该群发电邮给所有的会员。
- 有关审计后的财务报告(2010年)与会者在讨论后,进行举手表决,除 钟庭辉,张瑞良反对及许雪卿弃权外,其他人无异议,因此由蔡德明提 议,罗荣基附议,通过。

There are 75 out of the total voting membership of 157 attended the AGM, ²which is in accordance with the SCFA's Constitution 12 that at least one-tenth of the voting member or thirty voting members, whichever is the lesser, present at a general meeting shall form a quorum. The Chairman therefore declared the commencement of the meeting.

Opening Report:

- The Chairman extended his gratitude to the President of Ee Hoe Hean Club Lim Chin Joo, for offering the Club as the venue for this meeting, and also expressed his appreciation for the presence of Mr. C. S. Lee and all other attendees.
- The Chairman gave a brief report of the main activities of SCFA over the past 2 years:
 - The most important event was The 5th Conference on ASEAN-China People-To-People Friendship Organisations (CACPPFO).
 - This conference was held at Sentosa, Singapore, in July 2010, and was attended by Ministry of Foreign Affairs of Singapore, Embassy of China, SCFA and other friendship associations from 10 ASEAN countries and China.Six different seminars were held simultaneously, and the conference was a great success. Mdm Gu Siu-Lian, the President of China-Asean Association expressed her view that the 5th CACPPFO was successfully organized. Our Association was invited to hold a forum on "Tertiary Education in Asean and China" at the 6th CACPPFO in Bangkok. The Logo designed by us for the 5th Conference was adopted for the 6th Conference and will again be used for the 7th Conference to be held in Vietnam.
 - > Strengthening the bond with the Embassy of PRC in Singapore; there were more activities organized for members to interact with the Embassy.

- Activities with Alumni Associations of China's universities. Over ten universities from China, like Tsinghua University, Peking University, Xiamen University etc., have alumni associations in Singapore, with whom SCFA has also established very good cooperative relationships. SCFA has continued to establish bonding with Alumni Associations of China's universities in Singapore.
- Reception of foreign delegations and organising visits to China are still maintained as SCFA's routine.
- Providing assistance for the Chinese government officials sent to Singapore for training. In the past two years, SCFA has been actively coordinating the trainings with NUS, NTU etc.

I. Confirm the minutes of the 16th Annual General Meeting held on 26 February 2010

- Chairman asked all the members present to check the minutes, and any mistake or suggestion could be raised.
- Chwee Meng Chong proposed that members could check the minutes after the conference, and if they have any questions or suggestions, they could then submit them to the committee by mail.
- Chairman expressed his gratitude towards Mr Chwee for attending the meeting.
- Mr Lim Chin Joo however proposed that members present should read through the minutes and if no amendment raised should be adopted.
- As no amendment was raised, it was proposed by Mr Chua Teck Ming and seconded by Mr Loh Weng Kee to adopt the minutes.

II. To receive the audited accounts for the period March to December 2009

- Mr Oh Bin Cheng said that he could not agree that two AGMs were held together and also could not accept the financial report as this was against the rules. He said that he would leave the meeting. Mr Ung tried to persuade him to stay back so that he would be able to understand the reasons and know the details, he could also speak to the members and let them know his views.But Mr Oh insisted and left before the commencement of agenda 1.
- Mr Ung pointed out that there was an email sent to all members that if financial reports were adopted by the meeting, all members would be liable. The same email



also questioned whether his (Ung's) performance of the duties of a secretary was in accordance with the constitution.

- Mr Ung clarified that if there were problems in the financial reports of an association, only the Management Committee and auditor were responsible. According to our constitution, members needed only to "considered" and not "approved" the financial reports.
- With regard to his performance of the duties of secretary, Clause 24 said that "Ordinary Management Committee Members shall assist in the general administration of the Association and performance duties assigned by the Management Committee from time to time." He was assigned by the Committee to perform the duties. There was also suggestion that the Management Committee should manage its affairs in accordance to democratic procedure. Mr Ung pointed out that the essence of democracy is "majority rules". This was exactly the principle which the Management Committee followed. He hoped that members should not be influenced by these emails.
- After deliberation the audited account (for the period March 2009 to December 2009) were adopted. Proposed by Mr Lim Chin Joo and seconded by Mr Chwee Meng Chong.

III. Audited Account for Year 2010

- Mr Ronald Chang said these were not according to rules and he opposed to them. He said he had requested Management Committee to hold EGM, but the request was not entertained.
- There was also email alleging that the Management Committee did not handle its matters according to Constitution. There was no Management Committee Meeting held every two months. Mr Ung clarified that the Management Committee had tried its best to do things in accordance to constitution. In the year 2010, the Association was busy preparing the organization of the 5th CACPPFO. There were altogether 14 meetings involving all Committee Members (4 Management Committee Meetings and 10 CACPPFO Organizing Committee Meetings (all Management Committee Members were also organizing Committee Members)). In addition to these, there were many small working committee meetings. There was not enough time to hold Management Committee Meetings bi-monthly. Many members would understand this.



- There was also assertion that the Association had issued cheques with amount exceeding \$10,000 and this was against Clause 21(a) of the Constitution that the Management Committee had power to authorize the expenditure of not exceeding \$10,000.00 per month. Mr Ung pointed out that these money were not day to day or running expense of the Association. These were money raised for Xinjiang Province and donation raised for Sichuan earthquake victims and issuing of the cheques had not violated Clause 21(a) of the Constitution. He also said that with regard to the expense on the 5th CACPPFO, President Phua had promised to the Management Committee that he would bear the deficit. In actual fact, he had spent \$73,000 on the conference (Exact figure was \$73,376.32)
- Mr Lim Chin Joo said that all of us should support the Conference. He himself had contributed \$2,000. He was of the view that if any member had any dissatisfaction towards the Management Committee, he should raise it directly to the Management Committee and not to send massive emails to all members.
- With regard to the financial reports (year 2010), after careful deliberation, it was adopted. However, Mr Chung Ting Fai and Mr Ronald Chan opposed and Mdm Koh Sok Kheng abstained from voting.

C. C. Yang was appointed as the auditor for the year of 2011.

VI. Election of the 9th Management Committee members

- A total of 31 candidates stood in for the 9th Management Committee members, only 21 were elected as new committee members.
- All together 75 votes were distributed the participating members, 66 votes were in the voting box and 3 tickets were invalid (one empty, the other two chose more than 21 persons), only 63 tickets valid.
- The recording process was supervised by Chung Ting Fai, counted by Lee Sze Shyan, called out by Chan Sow Wing and recorded on the whiteboard by Loh Weng Kee. The result was announced by Loh Weng Kee.
- The vote result: As above in the Chinese version.
